

WAIVER AND REALEASE OF LIABILTY AGREEMENT

Please read carefully before signing, this is a release of liability and waiver of certain legal rights. In consideration for my being permitted to participate in the activities of hunting, camping, visiting or touring Alligator Alley Outfitters, LLC's properties, I agree to the following waiver & release: **This one signed waiver will be in effect for all hunt for all future hunting and visiting dates now and in the future!**

I acknowledge that hunting, camping and visiting or touring has inherent risk, hazards and dangers for anyone that cannot be eliminated, particularly in a wilderness environment.

I UNDERSTAND THAT THESE RISK, HAZARDS AND DANGERS INCLUDE WITHOUT LIMITATION:

1. The risk of handling firearms and being near others that have firearms in their possession;
2. The risk of injury from ammunition, knives, spears and projectiles from any firearms or Bows;
3. Walking in rugged terrain with possible encounters with dangerous wildlife;
4. Inclement weather condition;
5. The risk of injuries from riding on all terrain vehicles (ATV) or any vehicle used on our properties;
6. The risk of serious injury and or death from the use of tree stands, Blinds or rented weapons;
7. All other risks involved with outdoor activity **KNOWN OR UNKOWN, LISTED ABOVE OR NOT LISTED;**

I understand the risk, hazards, and dangers as described above and have had the opportunity to discuss them with our guide. I understand that these activities may require good physical conditioning and a degree of skill and knowledge. I believe that I am good enough physical condition to participate in these activities safely. I understand that I have responsibilities. My participation of this activity is purely voluntary. No one is forcing me to participate and I elect to participate in spite of any risk. I am voluntarily using the services of any property owners land, Alligator Alley Outfitters LLC, Outdoor Enterprises, South Jones Trust with full knowledge of inherent risk, hazards and dangers involved **and hereby assume and accept any and all risk of injury, paralysis, or death.** No changes to this agreement may be made without the express written permission of owners.

LASTLY, I, for myself, my heirs, successors, executors, and subrogees, hereby KNOWINGLY AND INTENTIONALLY WAIVE AND RELEASE, NOW AND IN THE FUTURE, IMDEMNIFY AND HOLD HARMLESS all owners of property used, Outdoor Enterprises, any trust related to, or connected with the hunting property, their directors, officers, agents, employees, guides, affiliates, and any volunteers from and against any and all claims, actions, causes of action, liabilities, law suits, expenses (including reasonable attorney's fees) which are related to, arise out of, or are in any way connected with my participation in this activity including, but not limited to, NEGLIGENCE of any kind or nature, whether foreseen or unforeseen, arising directly or indirectly out of any damage, loss, injury, paralysis, or death to me or my property as a result of my engaging in these activities or the use of these services, animals or equipment, whether such damage, loss, injury, paralysis, or death results from negligence of any owner, outdoor enterprises, or any trust related to, or connected with the hunting property, their directors, officers, agents, employees, affiliates, and volunteers or from some other cause. I, for myself, my heirs, my successors, executors, and subrogees, further agree not to sue any owner of any property used, outdoor enterprises, and any trust related to, or connected with the hunting property, their directors, officers, agents, employees, affiliates, and volunteers as a result of any injury, paralysis, or death suffered in connection with my use and participation in the activities of hunting, camping or touring Guides properties, other properties owners land used, and or any trust properties used. **I HAVE CAREFULLY READ, CLEARLY UNDERSTAND, AND VOLUNTARILY SIGN THIS WAIVER AND RELEASE AGREEMENT.**
